Overall migration: 2 hours at 70°C, used simulants B, D1 and 95% ethanol and 10 days at 40°C used simulants B, D1 and 95% ethanol
Specific migration acrylonitrile: 2 hours at 70°C, used simulant A, B and D2
- Ratio of food contact surface area to volume used to determine the compliance of the article:
Volume ratio = 6 dm²/ kg
